Thanks for considering a donation to Third Act. We work hard to mobilize Americans over 60 to protect our climate, safeguard our democracy, and leave behind a just, abundant world for future generations. There are three thrusts to Third Act's work.

Third Act Initiative is a 501c4 registered nonprofit organization. This includes some political-electoral work, but is not for specific candidates. Donations here are NOT tax deductible. These funds give us the greatest flexibility to plan and organize campaigns, and respond to real-time necessities.

Third Act Education Fund is a 501c3 registered nonprofit. Funds given here ARE tax deductible and support training and communications for our volunteers. Donations made from foundations, donor advised funds (DAF), and most required minimum distributions (RMD) for a Qualified Charitable Distribution (QCD), are given here for tax purposes.

GrayPAC is Third Act's political action committee that supports intense and focused work around elections, thus is not tax deductible. This money allows us to support specific candidates at high levels which is not possible with our other nonprofit statuses.
